About

Incubators play a critical role in nurturing start-ups and social enterprises. Although there are approximately 200 incubators in India, the boom in start-ups and social enterprises has fuelled a demand for incubator support with estimates placing the demand at 1,000 incubators by 2020. In addition to recent Government priorities such as Startup and Make in India promotion, the recent Companies Act (2014) permits funding to Government approved Incubators as a CSR activity. These factors combined make a strong case for corporate participation in supporting incubators and enabling social enterprises. Keynote Address: Mr. H K. Mittal, Adviser Member Secretary National Science & Technology Entrepreneurship Development Board (NSTEDB)

An alumni of the National Dairy Research Institute (1981) and the Indian Institute of Management (IIM) Ahmedabad(1984), Shri Harkesh Mittal has been instrumental in giving a new vibrancy to promoting the innovation and entrepreneurial acumen among a wide section of Indian entrepreneurs ranging from simple rural industries to high end technological enterprises. His two decades long association with the Government has coincided with the beginning of India's economic liberalization initiatives. With his untiring efforts and personal initiative, Shri Mittal has made the innovation and entrepreneurship programme of Department of Science & Technology a much sought after programme by the individual entrepreneurs as well as by the industry and technological circles - not only in India but among the industrially advanced countries of the world.

Shri Mittal has been instrumental in involving the private sector - both national and international- in the task of innovation and entrepreneurship development in India. Companies like Intel, TCS, Lockheed Martin, Boeing, P&G, The Economic Times, etc. have now been involved in this task and quite many of them are making matching contribution and are bringing world class technology commercialization knowledge to India.

Fireside Chat: Impact and Social Entrepreneurship

Social entrepreneurship is the buzzword today! With the boom in such enterprises, this session aims to bring together a group of selected entrepreneurs who are creating significant social impact on the ground and to hear from them about their service and product offerings in fields such as education, health and agriculture, among others. The scope of the session is to walk through the journey of these entrepreneurs and to discover how incubators and corporates can deepen their support and collaborate with social enterprises. It will also touch up on the relation between incubators, investors and these enterprises and what more is needed to support the same in India.



1. Kavita Anand, Executive Director, Adhyayan Quality Education Services Pvt. Ltd.

Kavita Anand leads the school set-up arm of Adhyayan – from the first stages of school planning to providing support and advice to the newly set up schools. As the head of Training and Development for Adhyayan she manages and conducts training programmes for teacher induction, school improvement and leadership and management.

In addition to training school leaders, she conducts external validations of schools using the SSRE diagnostic. Kavita also provides consultation services in Leadership and Management for the new teacher education project across India and English in Action Programmes through the Open University.

Kavita's work has positively influenced students, teachers and administrators across socio-economic groups in urban and rural settings through a range of roles in her professional experience spanning 24 years. She is part of several committees, boards and organisations working towards providing quality education in India.



2. Jatin Singh, Founder and CEO, Skymet Weather Pvt. Ltd.

A journalist by profession, Jatin Singh took a huge leap into the notorious business of agriculture. As a visionary, Jatin Singh first conceptualized the idea of setting up a weather company to provide accurate and timely weather information, when he witnessed first-hand the hurdles faced by the media houses in gathering weather related data. A deep-rooted fascination for weather urged him to launch Skymet in 2003, with the aim to make weather forecasting reliable and accessible.

Skymet is India's first private weather forecasting and monitoring agency. His intention was explicit as he believes that 'forewarned is forearmed'. The company has ushered in weather solutions for sectors as varied as energy (distribution and renewables), shipping, agriculture (advisories and remote sensing based crop yield, acreage and health estimation), and risk (agriculture and energy) in India.

3. Ratul Narain, Founder, Bempu Health Pvt. Ltd.



Ratul Narain has moved to India from the U.S. to pursue his vision to improve health outcomes in low-resource parts of the world. While growing up, he travelled to several low-income countries including India, where he saw first-hand the disparity in quality-of-life that exists. Through these exposures, he developed a deep interest in health technologies. In 2014, Ratul was selected for the Echoing Green Fellowship for Social Entrepreneurship. He also has over 9 years of experience developing medical devices in companies like Boston Scientific, Johnson & Johnson Cordis, and Embrace Innovations.

Ratul holds a B.S. and M.S. in Mechanical Engineering from Stanford University, and can speak 4 languages.
