


# LEARNING OUTCOMES OF THE PROGRAM


After the successful completion of the program, individuals are expected to:

#### **ELIGIBILITY CRITERA**


- CEOs, Chief Functionaries / Executive Directors of Non Profit Organizations (NPOs).

# **DOCUMENTS REQUIRED**

Along with the filled in registration form, the candidate is required to submit the following:

- Curriculum Vitae
- Covering letter stating why would you like to participate in this course.
- Experience certificate.
- Identity Proof
  - In case of International applicants, copy of passport is required.
  - In case of Indian applicants, copy of passport/ driving license/voter's identity card/employer's identity card, any of these would do.
